Part IV Narrative Description of Your Activities

Overview

It is the purpose of Mission Wings International, Inc to provide disadvantaged people living in remote and isolated areas with medical evacuation flights, humanitarian aid and to provide disaster relief during natural and man-made disasters.

It is also our purpose to provide air transportation services for churches, ministries and missionaries facilitating their work by saving them time and enabling them access into remote locations.

It is our goal to be available to help people, through the use of aviation and other means, during times of extraordinary tribulation and to serve churches, missionaries and other non-profit organizations with air transportation needs.

Doing Business As

Mission Wings International, Inc may conduct its daily activities as MissionWings.

Activities

Medical Flights

Mission Wings International, Inc aims to provide emergency medical relief flights to remotely located and isolated individuals who are disadvantaged. We primarily serve the severely disadvantaged who are affected by a lack of existing community services. The primary purpose of these flights is to transport individuals with life-threatening or potentially life-threatening injuries or illnesses from areas that are distantly removed or have limited road access to a medical treatment facility. We may also choose to transport these individuals by aircraft to a location where they can receive quick and reliable ground transportation to a medical treatment facility.

An example of one of these flights would be flying a mother with child birth complications from a remote village airstrip to a city airport to receive ambulance transportation to a hospital that has the facilities to give proper care.

The average cost for one of these flights is estimated at \$560.00 USD and will be provided at no cost to individuals of poverty.

Disaster Relief Services

Mission Wings International, Inc aims to distribute disaster relief aid primarily, but not solely, to areas with poor, limited or non-existent road infrastructure. Although, we primarily target the severely disadvantaged, we will serve anyone suffering from the effect of disasters. Mission Wings International, Inc operates and focuses its resources locally and globally to communities who meet the aforementioned criteria regardless of their geographical location.

Examples of the such populations would be those affected by natural disasters and the displaced victims of sectarian and ethnic violence such as the devastating results of the earthquake of 2010 in Haiti and refugees of the Rwanda civil war in Africa.

We aim to distribute disaster relief aid by flying in supplies and organizing volunteers and/or staff to serve in the affected areas by coordinating and carrying out the distribution of food, water, clothing, sanitary supplies, etc. On occasions, in a location where it is impossible to land aircraft, disaster relief may be air dropped by parachute and supplies may or may not be distributed by volunteers or staff depending on the difficulty of safely inserting personnel into the location. The provisions distributed will be derived from our disaster relief fund, public support and partnering organizations.

The cost of disaster relief services can not be determined as each situation is different and can vary dramatically. Disaster relief services are provided at no cost to the individuals served.

Humanitarian Aid Distribution

Mission Wings International, Inc aims to distribute humanitarian aid to those in need. We will primarily target our distribution to remote and isolated communities and people groups whom are severely disadvantaged and affected by a lack of existing community resources. Humanitarian aid distributed will be derived from our humanitarian aid fund, public support and partnering organizations. These services are provided to the targeted people at no cost to those served.

Medical Access Support

To help disadvantaged people with medical access Mission Wings International, Inc may at times partner with other organizations and volunteering nurses and doctors to set up temporary clinics or field hospitals to provide medical services to isolated and remotely located disadvantaged populations during times of outbreaks and other health and medical crises. A scenario like this may occur when there is such a demand for medical treatment in one location from an outbreak that it is easier to bring medical help to the affected area than to evacuate affected individuals from that area. During such an event Mission Wings International, Inc will provide for the transportation needs of healthcare professionals and medical supplies and other necessary goods. We will also provide any volunteer help needed to assist medical personal in these situations.

Air Transportation for Missionaries, Ministries and Non-profits

Mission Wings International, aims to provide transportation for missionaries in need of air transportation services. These services are primarily, but not limited to, providing air transportation of individuals, supplies and cargo into remote areas with limited or no road access.

An example of this service would be flying building supplies into a remote village with no road access for the construction of a school or church.

These services are provided to missionaries, ministries and other non-profits who are affiliates within an affiliate classification created by the board of directors of Mission Wings International, Inc as outlined in our Bylaws Article III section 3.02.

The average cost for one flight is estimated at \$480. Mission Wings International, Inc will apply fees for the use of this service.

Education

Mission Wings International, Inc provides education on the impact of a lack of medical access and the effects disasters have on disadvantaged people. We provide this information by presenting live media interviews, lectures and slideshows at schools, churches, conventions and other public venues. These presentations focus on the effects, current efforts and solutions to reach and help others affected by the lack of medical access and disasters.

Mission Wings International, Inc also provides education on how our services help missionaries access remote areas lacking efficient road infrastructure and facilitate them in their work.

We take advantage of various social media outlets such as discussion forums, blogs and social networking sites to educate people of the needs and our activities. We also chronicle our efforts and activities on the corporation's website.

By offering educational events as well as our publications and website, Mission Wings International, Inc is educating the public on subjects useful to individuals and beneficial to the broader community.

Ambassador Program

Mission Wings International, Inc seeks opportunities for community outreach through our ambassador program which allows individuals to volunteer as Ambassadors. As Ambassadors, individuals will help in our mission by raising awareness and funds through hosting of events and speaking engagements. Through these means, our mission will be brought to the attention of diverse audiences. Individuals acting as Ambassadors must be affiliates within an affiliate classification created by the board of directors of Mission Wings International, Inc as outlined in our Bylaws Article III section 3.02.

The funds received through the entirety of the Ambassador Program's activities will be used exclusively for the charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code and will not be used for personal gains of any sort.

Distribution to Other Organizations and Individuals

We do not fundraise for any specific organization and Mission Wings International, Inc is not organized solely to contribute or fundraise for any specific entity. However, at the discretion of the board of directors we will provide air transport services to other non-profit organizations and may, if the contributions further our exempt status, choose to contribute to other organizations financially who share a similar mission.

An example of an organization to which we may contribute is "FEA Ministries Inc" (EIN: 59-0999157) which is a U.S.-based, nonprofit, nonpartisan 501 (c)(3) tax-exempt charitable organization that focuses on spiritual, educational, health and humanitarian needs of individuals around the world. Mission Wings International, Inc may exercise its right under law to contribute to non-501 (c)(3) organizations only on the condition that Mission Wings International, Inc retains control over the use of the funds and records are maintained showing that the funds are used exclusively for charitable purposes in accordance to our mission.

Programs for Volunteers

Mission Wings International, Inc, per the discretion of the board of directors, may provide internships or volunteer opportunities which will provide opportunities for involvement in outreach activities and programs in order to have a greater impact. One of the activities that volunteers may be involved in is the distribution of humanitarian and disaster relief aid. Such activities shall always be free of charge to participants and will not include compensation to the volunteers.

Multimedia

It is our goal to bring awareness from every medium possible and this includes documentaries, videos and photos of our activities, projects, programs and expeditions. By documenting and reporting our efforts we intend to broaden our outreach. These multimedia features will be recorded by our volunteers, staff and employees and will be available to the public.

Foreign Activities

In general, our foreign activities fall into eight (8) categories: expeditions, contributions, disaster relief aid, humanitarian aid, air transportation of missionaries, medical flights, medical service and educational programs.

- Expeditions will include trips in which volunteers, and/or employees travel to prospective areas in foreign countries to research the viability of setting up operations in that area and/or to educate others about our mission in current or prospective areas of operation.
- Contributions will include assistance given to individuals or organizations which have been selected by the board of directors after conducting due diligence and a thorough investigation. The process of selection is in accordance with all applicable laws and regulations concerning our exempt status such as collecting information (i.e. physical address, phone number, mailing address, website, relationships with other organizations, financial standing both past and present, and governance). It is further detailed in our Narrative of our Activities subtitled: Distribution to Other Organizations and Individuals.

- Disaster relief will include our efforts to provide assistance to victims of natural disasters and/or of sectarian and ethnic violence as has been detailed in our Narrative of our Activities subtitled: Disaster Relief Services.
- Humanitarian aid will include our efforts to provide aid to individuals suffering from lack of basic supplies for daily living such as food, clothing, shelter, clean water, etc. This is further described in our Narrative of our Activities subtitled: Humanitarian Aid Distribution.
- Air transportation of missionaries will include our services to missionaries serving in foreign countries which have been approved by the board of directors after conducting due diligence and a thorough investigation. The process of selection is in accordance with all applicable laws and regulations concerning our exempt status such as collecting information (i.e. physical address, phone number, mailing address, website, relationships with other organizations, financial standing which includes past and present, and governance).
- Medical flights will include our services to disadvantaged individuals who need medical evacuation. This has been further detailed in our Narrative of our Activities subtitled: Medical Flights
- Medical Service will include our service to bring medical help to communities affected by large epidemics as has been detailed in our Narrative of our Activities subtitled: Medical Service.
- Educational programs will include our efforts to provide educational based lectures, slideshows, and in-field training and instruction as has been detailed more in our Narrative of our Activities subtitled: Education.

Please Note:

- Section 1.501(c)(3)-1(d)(2) of the regulations states that the term "charitable" is used in section 501(c)(3) of the Code in its generally accepted legal sense and includes the defense of human and civil rights secured by law.
- Section 1.501(c)(3)-1(d)(2) of the Income Tax Regulations states that the term "charitable" is used in section 501(c)(3) of the Code in its generally accepted legal sense and includes the advancement of education.
- Section 1.501(c)(3)-1(d)(3)(i)(a) of the regulations states that the term educational, as used in IRC 501(c)(3), relates to the instruction or training of the individual for the purpose of improving or developing his capabilities or the instruction of the public on subjects useful to the individual and beneficial to the community.

Financial Information

The sources of the corporation's income derive from personal resources, public donations and corporate donations. Additional income sources will include grants, sponsorship and fundraising. The corporation disposes of its income through the decisions made by its board of directors or through the decisions of the duly elected treasurer, whose power to pay expenses is set out by the board or the corporation's bylaws in accordance to the corporation's purpose. Expenses paid by the corporation include, but are not limited to: equipment purchases and rentals, employee salary, lodging, insurance premiums, internet web site fees, publications, postage fees, advertising, and miscellaneous board expenses.

Mail Solicitations

We will be sending fundraising letters to businesses and individuals at least annually to request that they donate funds to support Mission Wings International, Inc or to be cordially invited to attend our annual fundraising banquet and auction, etc.

Email Solicitation

We will be utilizing internet solicitation methods, including but not limited to email, social media contacts and other mediums.

Personal Solicitation

We will be fundraising by approaching a broad spectrum of entities and individuals in person to share the mission of Mission Wings International, Inc and seek public support.

Vehicle, Boat, Plane, or Similar Donations

We will solicit and accept in-kind donations with the intent of using the vehicles for the corporation's mission.

Foundation Grant Solicitations

We will be applying for private or public foundation grants. We have no current arrangement for this method at this time.

Phone Solicitation

We will be fundraising by telephone solicitation. This will involve calling prospective or existing donors and asking for support.

Accept Donations on Your Website

We will accept donations on our website. This function will be accessible through a "donate" tab on the website of the corporation. The payments are processed by PayPal, Inc. and are directed to the corporation's bank account.

Other

<u>Slideshows and Lectures.</u> We will be accepting donations during our lectures and slideshow program and expeditions. (Please see the Narrative of our Activities for further information regarding this activity.)

Small Scale Fundraising Events. At times we will be holding road-side small-scale fundraising events. The work performed for such events shall be "Volunteer Labor" and without compensation. The material used for such events shall only come from the gifts or contributed products. Volunteer charity lemonade or cookie sale would be an example.

Banquet and Auctions. We will occasionally hold a fundraising banquet and/or auction not to exceed once annually. All auction items will be from the gifts or contributed merchandise and all the work performed for such events shall be volunteer labor and without compensation.

<u>Web-related Donations.</u> We may make arrangements with commercial organizations for donations based on sales referrals. For example, some web sites (such as Amazon.com) allow nonprofit organizations to receive donations for sales which were referred from their website. Some local businesses in our area might also make such offers to non-profit organizations. We would only consider this for items and services that do not contradict the organization's activities and mission. We currently have no specific plans or contracts, but it's prudent to mention the possibility.

<u>Sale of Merchandise.</u> We will have shirts, hats, mugs and similar items available through our website which will bear our logo and/or mission statement. We may also have other items available. Any revenue from this activity will only be used to fund the organization. We have no current arrangement or contract for this

Line 4c. Do you or will you engage in fundraising activities for other organizations?

No. We do not fundraise for any specific organization and Mission Wings International, Inc is not organized solely to contribute or fundraise for any specific entity. However, at the discretion of the board of directors we may, at times, choose to contribute to other 501 (c)(3) organizations which share a similar mission only if the contributions further our exempt status. (Please see the Narrative of our Activities for more information regarding how we contribute to other organizations.)

Mission Wings International, Inc is primarily based in the state of Ohio, however, we will engage in fundraising in all 50 states of the United States whether via internet solicitation, mailouts, banquets or activities such as our ambassador program or slide-shows and presentations. For more information about these activities please refer to the Narrative of Our Activities.

We will not raise funds for other organizations; No other organization will raise funds for us and we will only fundraise for ourselves. This rule holds true for all 50 States of the United States.

Line 4e. Do you or will you maintain separate accounts for any contributor under which the contributor has the right to advise on the use or distribution of funds?

We do not anticipate soliciting contributions where the donor has the right to advise how to use or distribute the funds. However, we will endeavor to comply with and recognize special requests, notes, terms and conditions which are specified by contributors and will maintain a separate account for that specific donation. An example of this rule is foundation grants. There may be situations whereby we solicit a foundation grant for a specific purpose; (e.g. education) and in those cases the grant, if awarded, will probably have restrictions on the activities it can support. Honoring those terms is inherent in the grant application process.

Line 10. Do you or will you publish, own, or have rights in music, literature, tapes, artworks, choreography, scientific discoveries, or other intellectual property? Yes, we may own artworks, literature, tapes or other intellectual property. Any copyrights, patents or trademarks will be owned solely by Mission Wings International, Inc. for use or distribution by the corporation. There will be no fees or charges associated with the use of our copyrights, patents or trademarks. We reserve the right to allow use of our copyrights, patents or trademarks by other organizations or individuals by permission. Any items produced would be either done in-house or subcontracted. Distribution of any items would be done through our website, fundraising events or other public events.

Line 11. Do you or will you accept contributions of: real property; conservation easements; closely held securities; intellectual property such as patents, trademarks, and copyrights; works of music or art; licenses; royalties; automobiles, boats, planes, or other vehicles; or collectibles of any type?

We may accept contributions of: real property; closely held securities; intellectual property such as patents, trademarks, and copyrights; works of music or art; licenses; royalties; automobiles, boats, planes, or other vehicles; or collectibles of any type if said contributions further the purposes of this corporation. We will not accept donations if any conditions imposed by the donor on the contribution limit the corporation's ability to achieve its purposes or force this corporation to conduct activities that are not in furtherance of 501(c)(3) purposes. We will ensure that donations are accepted in accordance with 501(c)(3) regulations and we will properly determine fair market value according to IRS Publication 561. We currently have no specific plans, but it's prudent to mention the possibility.

Line 12a. Do you or will you operate in a foreign country or countries?

Answers to 12a, b, c and d are as follow:

It is the mission, duty and purpose of Mission Wings International, Inc to address, educate, coordinate and provide aid and relief through the use of aviation regardless of geographical position. Therefore, Mission Wings International, Inc may operate in any country and any region around the world where we may fulfill our mission and further our exempt status. Mission Wings International, Inc will obtain any required permits or permissions from the respective governments of any country we may operate in as required by law. This includes complying with the sanctions, embargoes, and other restrictions imposed by the United States government to such countries. For detailed information regarding our foreign activities please refer to the section of our Narrative of our Activities titled: Foreign activities. We may work closely^[1] with other non-profit and non-governmental organizations who are active participants in the same field. This will allow us to further our exempt status by providing the services and aid in a timely and effective manner.

(^[1]**Note:** Working closely with other organizations does not constitute a "Close Connection" as it is defined on page 11, line 15 of the IRS publication of instruction for form 1023. It merely refers to exchange of information, non-financial data, suggestions and advices on locations and ways to address and direct the focus based on up-to-date information.)

Please Note: Rev. Rul. 71-460, 1971-2 C.B. 231

"A domestic corporation that conducts a part or all of its charitable activities in a foreign country is not precluded from exemption under section 501(c)(3) of the Code. A domestic corporation that is otherwise exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 carries on part of its charitable activities in foreign countries. Held, since its activities are charitable within the meaning of section 501(c)(3) of the Code when carried on within the United States, the conduct of such activities

elsewhere does not preclude the organization from qualifying as an exempt organization under that section.

• The same conclusion applies if all of its charitable activities are carried on in foreign countries. With respect to deductibility of contributions to the organization under section 170 of the Code, see Revenue Ruling 63-252, C.B. 1963-2, 101 and Revenue Ruling 66-79, C.B. 1966-1, 48."

Line 13a. Do you or will you make grants, loans, or other distributions to organization(s)?

We do not offer or provide grants or loans to other organizations. Distributions to other organizations will be documented with copies of receipts, letters or other relevant documents. According to our bylaws, any distribution would have to be approved by the board of directors. The method of approval would be documented. Distributions to organizations have not yet occurred since the incorporation.

Please Note: Rev. Rul. 68-489, 1968-2 C.B. 210

- An organization will not jeopardize its exemption under section 501(c)(3) of the Code, even though it distributes funds to nonexempt organizations, provided it retains control and discretion over use of the funds for section 501(c)(3) purposes.
- An organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 distributed part of its funds to organizations not themselves exempt under that provision. The exempt organization ensured use of the funds for section 501(c)(3) purposes by limiting distributions to specific projects that are in furtherance of its own exempt purposes. It retains control and discretion as to the use of the funds and maintains records establishing that the funds were used for section 501(c)(3) purposes. Held, the distributions did not jeopardize the organization's exemption under section 501(c)(3) of the Code.

Line 13b. Describe how your grants, loans, or other distributions to organizations further your exempt purposes.

We do not offer or provide loans or grants to other organizations. Our contributions to other organizations will only include funds necessary to carry on our mission as it has been described in the Narrative of our Activities. These contributions would be funds donated to other organizations which are active in the field and are capable of addressing the issues of malnutrition, hunger, or disasters in a more timely and effective way than Mission Wings International, Inc would be able to at that given time. The board of directors will conduct due diligence and maintain control of any funds contributed to any organizations regardless of their exempt status and will comply with all applicable laws and guidelines to further our exempt status.

Line 14a. Do you or will you make grants, loans, or other distributions to foreign organizations?

We do not offer or provide grants or loans to any foreign or domestic organizations. If we decide that a contribution or distribution is necessary to fulfill our mission and our duty to further our exempt status, we will contribute at the discretion of the board of directors to foreign organizations. An example would be contributing to an organization that is providing humanitarian aid. If we decide to contribute to such an institution, we will stipulate how the funds shall be used and will require the recipient to provide us with detailed records and financial proof of how the funds were utilized.

Although adherence and compliance with the US Department of the Treasury's publication the "Voluntary Best Practice for US. Based Charities" is not mandatory, we the directors of Mission Wings International, Inc willfully and voluntarily recognize and put to practice these guidelines and suggestions to reduce, develop, re-evaluate and strengthen a risk-based approach to guard against the threat of diversion of charitable funds or exploitation of charitable activity by terrorist organizations and their support networks.

The recipients are selected by the content and quality of their essay, financial need, and average GPA.

4b. - Describe how you determine the number of grants that will be made annually.

As outlined in our bylaws, three (3) scholarships with equal values of up to \$10,000 each may be awarded annually

4c. - Describe how you determine the amount of each of your grants.

The amount of each scholarship will be determined by the board of directors each year and are dependent on the current financial state of the corporation, limited to the maximum allowed by our bylaws.

Students are required to display academic discipline by having maintained, at minimum, a GPA of 2.7 or equivalent over the previous semester of study. Students must also write an essay describing their future plans and goals, the reason of their need of the scholarship and how it will help them achieve their goals. They must also describe their current financial status and explain why they feel they should be the recipient of the scholarship. Students must also provide at least 3 letters of recommendation from previous or current instructors, teachers, employers, pastors or other professionals who are not of any family relation to the student.

5. - Describe your procedures for supervising the scholarships, fellowships, educational loans, or other educational grants. Describe whether you obtain reports and grade transcripts from recipients, or you pay grants directly to a school under an arrangement whereby the school will apply the grant funds only for enrolled students who are in good standing.
